Information Collection and Use

dublinbuddhistcentre.org collects information you provide such as name, contact details and email address for which you gave your consent when you signed up to receive emails from us. You are not required to provide this information except when booking a course, workshop or making any other online purchase.

We use your contact details so that we can contact you in case of issues with changes to classes, payment and similar circumstances and to send you our newsletter. We may also send you course notes or information relating to the course (e.g. recommended home practice for meditation) during or immediately after the course.

We use your banking details to process donations you have made us and to send you a receipt for such donations. We also use your personal data to claim Tax Relief on Charitable Donations, if applicable.

dublinbuddhistcentre.org also collects information about your use of our website including IP address, how much time you spend on the site and what you like to view, from both registered users and general visitors to the site. This data is used solely to manage the website, track usage and improve our website services. This information **does not identify the user personally** and may be shared with third-parties to provide more relevant services, for example with Google Analytics.

We keep your data until you inform us that you no longer wish to receive news from us.

If you are contacting the DBC via email or webpage contact form with an enquiry, we will only use your details for the purposes of responding to your email.

Email Opt In/Opt Out

We may use your email address to send periodic email newsletters regarding our classes, offers and events. However, we will only do so if you have given us your permission. If you change your mind at a later date, simply click on the option to unsubscribe near the bottom of the email newsletter.
